**Note to ALL Exhibitors: If your camper exceeds 25 feet, and/or you require more than 30amps, the only option for camping privileges will be on new lines, at the rate of \$30.00 a day which includes water, electric and sewage hookups.*

***Note to Horse Exhibitors: If your camper exceeds 25 feet, regardless of hook up desired, the only option for camping privileges is along the rail, on the new line, at the rate of \$30.00 a day which includes water, electric and sewage hook ups.*

If there are more requests than sites, preference will be given to those exhibitors with the greatest number of animals exhibited and/or the furthest distance from the fairgrounds. A lottery may be necessary. No campers may be brought to the grounds before the Saturday prior to opening of the Schaghticoke Fair. Campsites with water, electric and sewage hookups are available on a first come first serve basis for \$30.00 a day. **Minimum charge of \$180.00**

2016 Exhibitor's Camping Rules

The campsite requirements in #7-5.8 of the New York State Department of Health Code for an Agricultural Fairground requires a separation distance of 10 feet or greater be maintained between camping units including any add on structures or paraphernalia attached to the camping unit.

This means that after any awnings are opened, slide outs are slid out and folding campers are unfolded, there must be 10 feet between you and both of your neighbors at your closest point.

In our limited camping space you may be required to keep your awnings unfolded to maintain the 10 feet separation.

This separation between camping units may be reduced to 5 feet, only if no charcoal grills, gas grills or other open flame cooking devices are used within 10 feet of any camping unit. This includes the gas stove you might have in your camper.

Once again, due to our limited camping space you may be required to remove the supply tank to your gas cooking device to insure that there will be no open flame cooking in your camper.

Bonfires or recreational fires are strictly prohibited on the Schaghticoke Fairgrounds.

Permit must be visible at all times.

All persons occupying campers must have an exhibitor pass or purchase a week pass.

No one under 18 years of age may occupy a camper unless a chaperone is present.

If NYS Department of Health fines the Schaghticoke Fair for a violation which involves your camper /site you will be responsible in reimbursing the fair for that fine.

Campers are to be parked in designated areas only.

No dumping of waste water or gray water on the ground.

All campers must be equipped with a working fire extinguisher.
